

## 2022-2023 Verification Worksheets Independent Student-Tracking Group V1

Your 2022-2023 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. The law says that before awarding Federal Student Aid, we may ask you to confirm the information you reported on your FAFSA to verify that you provided correct information. The financial aid administrator at your school will compare your FAFSA with the information on this worksheet and with any other required documents. If there are differences, your FAFSA information may need to be corrected. You must complete and sign this worksheet, attach any required documents, and submit these documents to the financial aid administrator at your school. Your school may ask for additional information. If you have questions about verification, contact your financial aid administrator as soon as possible so that your financial aid will not be delayed.

### B. Independent Student's Family Information

**C. Independent Student's Income Information to Be Verified**

**1. TAX RETURN FILERS**

**Instructions:** Complete this section if the student and spouse **filed or will file** a 2020 IRS income tax return(s). The best way to verify income is by using the IRS Data Retrieval Tool (IRS DRT) that is part of FAFSA on the Web at [FAFSA.ed.gov](https://fafsa.ed.gov). In most cases, no further documentation is needed to verify 2020 income information that was transferred into the student's FAFSA using the IRS DRT if that information was not changed.

Check the box that applies:

- The student has used the IRS DRT in FAFSA on the Web to transfer 2020 IRS income tax return information into the student's FAFSA.
- The student has not yet used the IRS DRT in FAFSA on the Web, but will use the tool to transfer 2020 IRS income tax return information into the student's FAFSA once the 2020 IRS income tax return has been filed.
- The student is unable or chooses not to use the IRS DRT in FAFSA on the Web, and instead will provide the school a 2020 IRS Tax Return Transcript (s).

A 2020 IRS Tax Return Transcript may be obtained through:

- **Online Request-** Go to [www.irs.gov](http://www.irs.gov), under the Tools heading on the IRS homepage, click on the "Get A Tax Transcript". Click "Get Transcript by MAIL". Make sure to request the "IRS Tax Return Transcript" and NOT the "IRS Tax Account Transcript."
- **Telephone Request-** 1-800-908-9946
- **Paper Request Form-** Use the links to download IRS Form 4506-EZ or Form 4506-T

Use the Social Security Number (or the IRS individual taxpayer identification number) and the date of birth of the first person listed on the 2020 IRS Income tax return, and the address on file with the IRS (normally this will be the address used on the 2020 IRS income tax return).

In most cases, for electronic filers, 2020 IRS income tax return information is available for the IRS DRT or the IRS Tax Return Transcript within 2-3 weeks after the 2020 IRS income tax return has been accepted by the IRS. Generally, for filers of 2020 paper IRS income tax returns, the 2020 IRS income tax information is available for the IRS DRT or the IRS Tax Return Transcript within 8-11 weeks after the 2020 paper IRS income tax return has been received by the IRS.

If the student and spouse filed separate 2020 IRS income tax return, 2020 IRS Tax Return Transcripts must be provided for both.

- Check here if a 2020 IRS Tax Return Transcript (s) provided.
- Check here if a 2020 IRS Tax Return Transcript (s) will be provided later.

**2. TAX RETURN NONFILERS**

The instructions and certifications below apply to the student and spouse, if the student is married. Complete this section if the student and spouse will not file and are not required to file a 2020 income tax return with the IRS.

Check the box that applies.

- The student and spouse were not employed and had no income earned from work in 2020.  
The student and or spouse were employed in 2020 and have listed below the names of all employers, the amount earned from each employer in 2020, and whether an IRS W-2 form is provided. Provide copies of all 2020 IRS W-2 forms issued to the student and/ or spouse by their employers. List every employer even if they did not issue an IRS W-2 form.
